derivative characteristic of coupled matter-field systems. General relativity, it turns out, exhibits local gauge invariance. Noether's theorem also laid the foundation for later generations to apply local gauge invariance to theories of elementary particle interactions. In Dwight E. Neuenschwander's new edition of Emmy Noether's Wonderful Theorem, readers will encounter an updated explanation of Noether's "first" theorem. The discussion of local gauge invariance has been expanded into a detailed presentation of the motivation, proof, and applications of the "second" theorem, including Noether's resolution of concerns about general relativity.
