From cave paintings to computers, this overview of the history of books and communication is written for the layperson and student. It provides clear information on how books shaped and reflected major social, political, and literary developments. As a general guide, it moves from the earliest writing in the Middle East and Egypt to Greece, Rome, and early Christian contributions to book production and literacy. Major sections discuss publishing during the Middle Ages and how the invention of printing drastically changed and improved the distribution of knowledge. Later chapters take the reader from the age of encyclopedias in the seventeenth century to the great technological advances of the nineteenth and twentieth

centuries. For those who wish to pursue specific areas in the history of the book in greater detail, there are three parts devoted to additional reading with descriptive, critical annotations: general histories and bibliographies, scribes and printers, and printing to the modern period. Extensive notes and documentation will lead to additional sources.

No previous knowledge of data communications and related fields is required for understanding this text. It begins with the basic components of telephone and computer networks and their interaction, centralized and distributive processing networks, Local Area Networks (LANs), Metropolitan Area Networks (MANs), Wide Area Networks (WANs), the International Standards Organization (OSI) Management Model, network devices that operate at different layers of the OSI model, and the IEEE 802 Standards. Wiring types and network adapters are well covered, and a detailed discussion on wired and wireless transmissions including Bluetooth and Wi-Fi is included. An entire chapter is devoted to the various types of networks that one can select and use for his needs, the hardware and software required, and tasks such as security and safeguarding data from internal and external disasters that the network administrator must perform to maintain the network(s) he is responsible for. Two chapters serve as introductions to the Simple Network Management Protocol (SNMP) and Remote Monitoring (RMON). This text includes also five appendices with very useful

information on how computers use numbers to condition and distribute data from source to destination, and a design example to find the optimum path for connecting distant facilities. Each chapter includes True-False, Multiple-Choice, and problems to test the reader's understanding. Answers are also provided.

The European Union (EU) is a unique partnership in which member states have pooled sovereignty in certain policy areas and harmonized laws on a wide range of economic and political issues. The EU is the latest stage in a process of European integration begun after World War II, initially by six Western European countries, to promote peace, security, and economic development. The EU currently consists of 28 member states, including most of the formerly communist countries of Central and Eastern Europe. The EU is largely viewed as a cornerstone of European stability and prosperity. For much of the last decade, however, many EU countries have faced considerable economic difficulties. Despite an improved economic situation in the EU since 2017, economic pressures and societal changes have contributed to the rise of populist and antiestablishment political parties, at least some of which harbor anti-EU or "euroskeptic" sentiments. Such trends have complicated the EU's ability to deal with multiple internal and external challenges. Among the most prominent challenges are the pending departure of the United Kingdom (UK) from the EU ("Brexit"); democracy and rule-of-law concerns in Poland, Hungary, and other EU members; migration and related societal integration concerns; a resurgent Russia; and a heightened terrorism threat. Amid these difficult issues, some are questioning the future shape and character of the EU are

being. Supporters of the EU worry that some aspects of EU integration could be stopped or reversed. Others contend that the multiple crises could produce some beneficial reforms that ultimately would transform the EU into a more effective, cohesive entity. Recently, considerable attention has focused on developing a "multispeed EU," in which some EU members could pursue greater integration in specified areas and others could opt out. Successive U.S. Administrations and many Members of Congress long have supported the European integration project, viewing it as crucial to European peace and security and as a way to foster strong U.S. allies and trading partners. Despite some tensions over the years, the United States and the EU share a dynamic political partnership on various foreign policy issues and an extensive trade and investment relationship. How the EU evolves in the years ahead may have strategic and economic repercussions for the United States. At the same time, some EU leaders are concerned about President Trump's apparent skepticism of the EU and his reported assessment of the bloc as an economic competitor. Those of this view also worry that elements of the Trump Administration's "America First" foreign policy—such as the U.S. decision to withdraw from the 2015 multilateral nuclear deal with Iran—pit the United States against the EU. A number of European officials and analysts question whether traditional U.S. support for close U.S.-EU relations may be shifting and whether the United States will remain a reliable international partner. Some observers suggest that managing relations with the United States under the Trump Administration has emerged as another, somewhat unexpected, challenge for the EU. At the same time, many in the EU hope to preserve close

U.S.-EU ties and EU policymakers continue to seek to cooperate with the Trump Administration where possible on issues of common interest and concern. This report provides a brief history of the EU and the major challenges confronting the bloc. It also discusses the potential implications for the EU and for U.S.-EU relations.

This book aims to provide a critical appreciation of community justice, its origin and direction, and to engage with debates on the ways in which the trend towards community justice is changing the criminal justice system. At the same time it examines the inter-agency character of intervention and the developing idea of end-to-end offender management, and familiarises the reader with a number of more specialist areas, such as hate crime, mental illness, substance abuse, and victims.

History of Old Age is the first major study of the ways in which old age has been perceived in western culture throughout history. Georges Minois paints a vast fresco, starting with the first old man to relate his own story—an Egyptian scribe some 4500 years ago—and ending with the deaths of Elizabeth I and Henry IV in

the sixteenth century. Tracing the changing conceptions of the nature, value, and burden of the old, Minois argues that western history during this period is marked by great fluctuation in the social and political role of the aged. Minois shows how, in ancient Greece, the cult of youth and beauty on the one hand, and the reverence for the figure of the Homeric sage, on the other, created an ambivalent attitude toward the aged. This ambiguity appears again in the contrast between the active role that older citizens played in Roman politics and their depiction in satirical literature of the period. Christian literature in the Middle Ages also played a large part in defining society's perception of the old, both in the image of the revered holy sage and in the total condemnation of the aged sinner. Drawing on literary texts throughout, Minois considers the interrelation of literary, religious, medical, and political factors in determining the social fate of the elderly and their relationship to society. This book will be of great interest to social and cultural historians, as well as to general readers interested in the subject of the aged in society today.

Against the Modern World is the first history of Traditionalism, an important yet surprisingly little-known twentieth-century anti-modern movement.
