This book constitutes the proceedings of the 11th International Conference on Informatics in Schools: Situation, Evolution and Perspectives, ISSEP 2018, held in St. Petersburg, Russia, in October 2018. The 29 full papers presented in this volume were carefully reviewed and selected from 74 submissions. They were organized in topical sections named: role of programming and algorithmics in informatics for pupils of all ages; national concepts of teaching informatics; teacher education in informatics; contests and competitions in informatics; socio-psychological aspects of teaching informatics; and computer tools in teaching and studying informatics.

engineering, logical design and verification of computer software and hardware, deductive databases and software synthesis as well as logical techniques for analysis in the field of mechanical engineering. This volume covers some of the main subareas of computational logic and its applications.

The regular sessions covered topics such as web application design, intellectual property rights, security and fairness, distributed organizations, web usage analysis, modelling of web applications, electronic commerce success factors, electronic markets, XML, web mining, electronic negotiation, integrity and performance, facilitating electronic commerce, and mobile electronic commerce. There were two invited addresses at the conference. The first was by Anthony Finkelstein, University College London, UK on "A Foolish Consistency: Technical Challenges in Consistency Management". This was a common address to the DEXA, the DaWaK and the EC-Web attendees. The second talk was by Paul Timmers, European Commission, Information Technologies Directorate on "The Role of Technology for the e-Economy".

The significant amount of information available in any field requires a systematic and analytical approach to select the most critical information and anticipate major events. During the last decade, the world has witnessed a rapid expansion of applications of artificial intelligence (AI) and machine learning

(ML) algorithms to an increasingly broad range of financial markets and problems. Machine learning and AI algorithms facilitate this process understanding, modelling and forecasting the behaviour of the most relevant financial variables. The main contribution of this book is the presentation of new theoretical and applied AI perspectives to find solutions to unsolved finance questions. This volume proposes an optimal model for the volatility smile, for modelling high-frequency liquidity demand and supply and for the simulation of market microstructure features. Other new AI developments explored in this book includes building a universal model for a large number of stocks, developing predictive models based on the average price of the crowd, forecasting the stock price using the attention mechanism in a neural network, clustering multivariate time series into different market states, proposing a multivariate distance nonlinear causality test and filtering out false investment strategies with an unsupervised learning algorithm. Machine Learning and AI in Finance explores the most recent advances in the application of innovative machine learning and artificial intelligence models to predict financial time series, to simulate the structure of the financial markets, to explore nonlinear causality models, to test investment strategies and to price financial options. The chapters in this book were originally published as a special issue of the Quantitative Finance journal.

*Foundations of Software Science and Computation Structures* Springer

This book constitutes the refereed proceedings of the First International Conference on Fundamental Approaches to Software Engineering, FASE'98, held as part of the Joint European

Conferences on Theory and Practice of Software, ETAPS'98, held in Lisbon, Portugal, in March/April 1998. Besides two invited presentations and three system demonstrations, this volume presents 18 revised full papers selected from a total of 59 submissions. Among the various fundamental software engineering issues addressed are formal methods, specification languages, refinement, object-oriented modeling, software architectures, statecharts, model checking, etc.

'Network' is a heavily overloaded term, so that 'network analysis' means different things to different people. Mechanizing hypothesis formation is an approach to exploratory data analysis. Its development started in the 1960s inspired by the question "can computers formulate and verify scientific hypotheses?". The development resulted in a general theory of logic of discovery. It comprises theoretical calculi dealing with theoretical statements as well as observational calculi dealing with observational statements concerning finite results of observation. Both calculi are related through statistical hypotheses tests. A GUHA method is a tool of the logic of discovery. It uses a one-to-one relation between theoretical and observational statements to get all interesting theoretical statements. A GUHA procedure generates all interesting observational statements and verifies them in a given observational data. Output of the procedure consists of all observational statements true in the given data. Several GUHA procedures dealing with association rules, couples of association rules, action rules, histograms, couples of histograms, and patterns based on general contingency tables are involved in the LISp-Miner system developed at the Prague University of Economics and Business. Various results about observational calculi were achieved and applied together with the LISp-Miner system. The book covers a brief overview of logic of discovery. Many examples of applications of the GUHA procedures to solve real problems relevant to data mining and business intelligence are

presented. An overview of recent research results relevant to dealing with domain knowledge in data mining and its automation is provided. Firsthand experiences with implementation of the GUHA method in the Python language are presented.

STACS 2001 PHI Learning Pvt. Ltd.

This book presents in their basic form the most important models of computation, their basic programming paradigms, and their mathematical descriptions, both concrete and abstract. Each model is accompanied by relevant formal techniques for reasoning on it and for proving some properties. After preliminary chapters that introduce the notions of structure and meaning, semantic methods, inference rules, and logic programming, the authors arrange their chapters into parts on IMP, a simple imperative language; HOFL, a higher-order functional language; concurrent, nondeterministic and interactive models; and probabilistic/stochastic models. The authors have class-tested the book content over many years, and it will be valuable for graduate and advanced undergraduate students of theoretical computer science and distributed systems, and for researchers in this domain. Each chapter of the book concludes with a list of exercises addressing the key techniques introduced, solutions to selected exercises are offered at the end of the book.
